The special tour of the Clinton Presidential library was fascinating. I want to thank everyone responsible for the conference. Kudos to the Arkansas Association of Administrative Adjudicators for all their efforts.

Our president-elect, Bob Cohen, is hard at work planning and preparing for our 2009 Annual Conference in Orlando, Florida, scheduled for November 3-7, 2009. At the Little Rock Conference, I announced that the 2010 Midyear Meeting will be held in Montreal, Canada, May 30 to June 1, 2010, in conjunction with the 5th International Conference of the Canadian Council of Administrative Tribunals.

In terms of expanding benefits for NAALJ members, the NAALJ Board voted in Little Rock to reinstitute the challenge grant program for affiliates. The NAALJ News article has the details about the program, but in basic terms, NAALJ will waive the registration fee and provide a grant of \$500 for each affiliate to send one member to the Annual conference in Orlando. The Maryland Association of Administrative Adjudicators was originally established as a NAALJ affiliate in 1996. In 2003, after creation of a central panel agency in the District of Columbia, MAAA joined with administrative adjudicators in D.C. in establishing a single joint, local NAALJ affiliate, the Maryland and District of Columbia Association of Administration of Administrative Adjudicators (MDCAA). For several years, including two national conferences, that relationship worked well. However, as the membership base grew and the D.C. central panel agency matured, the leadership of

MAAA, based on input from the membership, believed that the time had come for each jurisdiction to have its own separate affiliate. To that end, in April of 2009 a resolution was passed dissolving MDCAA. With the dissolution of MDCAA, the Maryland only affiliate was reformed as the Maryland Association of Administrative Law Judiciary MAALJ. At the same time, a new D.C. affiliate was formed. MAALJ is still in its formative stages: new by-laws have been adopted and election of permanent officers and board members is tentatively scheduled for mid-September. Jim Murray, Charter Member of

the original affiliate and the last president of MDCAA, is the Interim President of MAALJ and Denise Shafer is the interim Secretary. Also taking lead roles are Scott Oakley and another Charter Member of the Original Affiliate and former NAALJ board member, Mike Nolan.

Everyone here is looking forward to a rejuvenated affiliate and for the tentative nature of the organization to be resolved. By the time of the annual conference in November our transition should be complete and we hope to send several representatives, at least one of whom can report on our progress.

### NEIL ALEXANDER SCHOLARSHIPS 2010

NAALJ offers two \$500 scholarships to assist NAALJ members attend a one-week resident course at the National Judicial College (NJC) in Reno, Nevada.

The Neil Alexander Scholarships are in honor of a NAALJ colleague, who at the time of his recent untimely death was chief hearing examiner of the D.C. Commission on Human Rights. He was co-chair of the 2007 NAALJ Annual Conference in Washington, D.C.

The NAALJ scholarships are to be used in combination with two scholarships that have been awarded to NAALJ by NJC.

The NJC scholarships are for a 50 percent tuition waiver for a one-week resident course. Civil mediation, mediation for ALJs and other mediation courses are not eligible for the scholarships.

Additional expenses to attend a course (conference fee, lodging, meals, travel and incidentals) are the responsibility of the recipient or his or her employer.

To apply for the scholarships, fill out and submit the application by November 15, 2009, and send to Judge Phyllis Carter, West Virginia Human Right Commission, 1321 Plaza East - Room 108A, Charles-



## Death of Judge Gladstone

A recent obituary in the Washington Post announced the death of Arthur Gladstone. Judge Gladstone's career in administrative

law went back to the pre World War II new deal. He was a chief ALJ for the Federal Communications Commission who after his retirement taught administrative law courses for many years at the National Judicial College. I had Judge Gladstone several times and made it a point to sit with him at lunch at least once every time I was at NJC taking courses. It was also my pleasure to be present when NAALJ presented him with the NAALJ Rosskopf award for career achievement by an ALJ. Judge Gladstone was also an early chair of the National Conference of the Administrative Law Judiciary (the voice of the ALJ in the American Bar Association).

Those of us who took courses under Judge Gladstone will never forget his admonition (sometimes repeated several times in his lectures)—“you are not a potted plant! As an ALJ you must take an active role directing the development of the record in your hearings.”

And once in the course of every lecture series, he would tell the class a joke about the great hunting dog, “lawyer” who all the hunters wanted to rent because he was such a good pointer and retriever until one hunting party started calling him “judge” (after that the dog became useless, he would just sit on his tail and bark all day).

Judge Gladstone also never tired of telling the story of the country lawyer who appeared before a very cranky big city judge in a court room that was not air conditioned on a hot day. Because of the heat all the windows were opened. After the judge had chewed the lawyer out several times, the judge asked why all the flies were swarming around the judge. The lawyer replied that they were called “circle flies” because they always circled around the rear end of a horse. The judge exploded, “Counsel, I hope you aren't comparing me to a horse's rear end.” The lawyer responded, “Of course not your honor. I have too much respect for the court. But you sure can't fool them circle flies.”

I wanted to preserve those stories since Judge Gladstone will no longer be around to tell them to his classes. He was a great role model and will be missed. We shall not see his like again.

Judge Gladstone's formal obituary in the Washington Post read as follows: Arthur A. Gladstone, 97, a retired lawyer with the Federal Communications Commis-

sion who helped shape a number of telecommunications regulations and rulings, died May 8, 2009, at his home in Reno, Nev., after a heart attack. He was a former Alexandria resident.

From 1939 to 1941, he was a lawyer with the Federal Power Commission in Washington. After serving in the Army and the Coast Guard during World War II, he joined the FCC.

He was involved in the development and regulation of mobile radio and telecommunications, wireless communications and transoceanic communications to Europe and Asia. His son recalled that in the 1940s and 1950s his father chartered boats in the Great Lakes and booked train trips to test developments in wireless communications.

Mr. Gladstone also was responsible for overseeing court proceedings during the breakup and reorganization of AT&T, and he helped develop regulations for public radio and television.

He was appointed an administrative law judge in 1962 and became a chief administrative law judge in 1969. He served until 1972.

He retired in 1972 and moved to Reno, where he developed the administrative law curriculum at the National Judicial College. He continued to teach at the college until age 91. He also taught himself Indian tribal law and became a tribal judge and later an Indian appellate court judge.



### New Hon. Arthur A. Gladstone Scholarship Established at the National Judicial College for Administrative Law Judiciary

This year, the NJC has received an exponential increase in the number of scholarship applications as a result of state revenues/budgets having an unheard of negative impact on both state courts and administrative agencies. As courts/agencies experience reduced funding, education budgets are the first to be eliminated. With generous support from private donors and the Bureau of Justice Administration, the NJC has been able to provide scholarships to enable judges to obtain much needed education.

There is currently a critical need for scholarships for Administrative Law Judges. Having used all scholarship funds available for ALJs, the NJC is seeking additional funding for ALJs to attend upcoming courses in 2009 and 2010. To address this need, NJC is turning to private donors and foundations for scholarship assistance.

Toward that goal, the NJC has established a new scholarship program in honor and memory of long-time adminis-

## Become A Charter Mentor or Life Mentor!!

There are only a few months left ... to join your fellow administrative adjudicators in becoming a CHARTER Mentor or Life Mentor of the National Administrative Law Judiciary Foundation (NALJF)!! Hopefully, you are aware from the February 2009 newsletter that NALJF, the public interest arm of NAALJ, embarked on a fundraising drive in late 2008 to increase the Foundation's assets.

One of the goals of this fundraising drive is being realized at the 2009 NAALJ Annual Meeting and Conference. This is the goal of reinstating the Challenge Grant Program, which encourages affiliates to select a member to attend the NAALJ annual meeting and conference with financial assistance from both the Foundation and the affiliate. (See related article in this newsletter about the Challenge Grant).

Other goals of the drive are to continue to sponsor the Fellowship, which provides the Fellow with a stipend of \$1,000 and expenses paid to the annual meeting and conference, and to sponsor at least two Neil Alexander Scholarships to assist members to attend courses at the National Judicial College.

Mentors – persons or other legal entities that make an annual contribution of not less than \$100.

Life Mentors – persons or other legal entities that make a one-time, lump-sum contribution of not less than \$1,000, or make an initial contribution of \$300 and a written pledge to contribute an additional \$900 over the next three years.

Contributors who become Mentors or Life Mentors in 2008 and 2009 will be Charter Mentors and Charter Life Mentors. Of course, contributions will be encouraged after 2009 in order to sustain the funding of these programs. ## ABA/NHTSA JUDICIAL FELLOWSHIP REPORT

In October of 2008, I was selected to be the Judicial Fellow for the American Bar Association's Judicial Division. This fellowship is sponsored by the United States Department of Transportation's National Highway Traffic Safety Administration (NHTSA). My fellowship duties include acting as a liaison between the ABA's Judicial Division, NHTSA, the National Judicial College, and the administrative judiciary and its national organizations. NAALJ is one of the national organizations that I will be reporting to.

While serving as the liaison, I will be promoting understanding, communication, cooperation, education, and collegiality between these organizations as it pertains to traffic safety, including the promotion of NHTSA priorities.

The NHTSA priorities that I am promoting include expanded use of DWI Courts and the use of Ignition Interlock Devices (IID). DWI Courts are similar to Drug Courts in that they take hardcore, repeat or high Blood Alcohol Content (BAC) offenders, and try to minimize future impaired driving by enrolling the offender in substance abuse treatment coupled with intensive probation overseen by the court in a post-adjudication setting. Initial studies have shown a significant decrease in recidivism for graduates of the programs. In 2008 there were 526 DWI Courts in the United States.

NHTSA is also encouraging the expanded use of Ignition Interlock Devices. In many states IID are not mandatory, but are left to the discretion of the sentencing judge in the criminal matter or the administrative law judge in the driver license revocation hearing. Studies show that the installation of an IID significantly lowers repeat drunk driver offenses

while the IID is installed.

In my duties as a Judicial Fellow I have attended a November 2008 Fellowship Orientation in Washington, D.C.; attend the ABA's Mid-Year Meeting in February in Boston, Massachusetts to report on my progress in Fellowship; participated in a Suspended/Revoked Working Group sponsored by the American Association of Motor Vehicle Administrators in Williamsburg, Virginia in March 2009; and I participated in a presentation at the NHTSA main office in Washington D.C. in May of 2009.

As the fellowship progresses I will keep member of NAALJ updated on my activities. I would also like to have input from you, NAALJ members, as to issues that you are facing with respect to driver safety issues. Please contact me at:
